OFFICIAL RULES

June 1st, 2026 – July 12th Entry: NO PURCHASE NECESSARY TO ENTER OR WIN AND WILL NOT IMPROVE CHANCE OF WINNING.

SPONSORS: Steel City Media, LLC. (KBEQ-Q104.3, KCKC- 102.1 BOB-FM, KFKF- 94.1 and KMXV- Mix 93.3) (“**Station**”) and Kansas City Current (“**Sponsor**”). Kansas City Current is referred to herein as Sponsor.

ENTRY REQUIREMENTS: To be considered a qualifying entry for the Giveaway, entrant information must be submitted between June 1 and July 12, 2026 via entry form on Station websites (www.Q104KC.com, www.1021BOBFM.com, www.KFKF.com or www.Mix93.xom.) Entries must be received by 11:59 p.m. CT on July 12, 2026. Illegible and/or incomplete entries are ineligible. Participants must give enough information on their entry for proper identification which may include name, address, age, phone number, and/or email address.

All entries who opt-in to receive more information from Sponsor will be shared with designated sponsor.

Entrants understand that Sponsor and Station are not liable for injuries, losses, or damages of any kind arising from participation in this promotion and acceptance, possession, and use of prize. Sponsor and Station are not responsible for any typographical or other error in the print of the offer, or administration of the Giveaway. Decisions of Sponsor and Station are final and binding in all respects.

HOW TO ENTER:

1. To enter the Giveaway, a person must submit his/her name, address, phone number, date of birth, and/or e-mail address via entry form. Each potential entrant must provide all information requested.
2. Entries will be submitted on-line via Station Contest Pages on each Station website: (www.Q104KC.com, www.1021BOBFM.com, www.KFKF.com or www.Mix93.xom.)
3. Multiple entries by means of software generated or other automated or mechanical processes will be disregarded at the sole discretion of Sponsor and Station.
4. Sponsor and Station cannot be held responsible for any entrant’s inability to successfully complete entry.
5. Entries will be void if electronically or mechanically reproduced, forged, defective, altered or obtained through unauthorized channels or if they contain production, typographical, electronic, mechanical or other errors.

6. Sponsor and Station reserve the right in their sole discretion to disqualify any entry at any time which, in Sponsor and Station's opinion, is offensive, contains unsuitable material, endangers the safety or well-being of any person, or if it is determined the entrant has not complied with these Official Rules.

WINNER SELECTION:

A random drawing for prizes will be held on or about July 13, 2026. "Station will conduct the drawing from among all eligible combined entries and select two (2) potential winners. The potential winners will be notified by telephone on or about July 13, 2026. If, after multiple daily attempts, Station is unable to reach the winner by Friday July 17, 2026 at 5:00pm CT, a drawing will be held to select another potential winner.

In the event that more than one (1) potential winner is inadvertently named for a Prize, a random drawing will be held among all such potential winners to select (1) winner. Sponsor and Station will determine all elements of winner selection in their sole discretion.

Prizes: The Winners will each receive two (2) premium-level tickets to either the July 29, 2026 or August 29, 2026 Kansas City Current home match and one (1) VIP tour of CPKC Stadium before the match they are attending (each a "Prize"). Ticket seat location to be determined at Sponsor's sole discretion and subject to availability. While Winners can indicate their match date preference, Station shall have the ability to award tickets to the match dates in its sole discretion. The approximate retail value of the Prize is six-hundred dollars (\$600).

All costs and expenses associated with any acceptance and use not specified herein as being provided, including but not limited to transportation costs, parking, food and beverages, souvenirs, gratuities and other expenses incurred by accepting and making use of any Prize, are the sole responsibility of the applicable Winner (and Winner's guests, as applicable). For game ticket prizes, each Winner and Winner's guest(s) will receive admission to the game or event only upon presentation of an admission ticket and will be subject to the rules and regulations of the venue while attending the game or event. Seat locations will be determined by Sponsor in its sole discretion. Unless otherwise agreed to by Sponsor, tickets will be available for pick-up at the applicable venue's will-call on the day of the game or event. If the Winner cannot attend on the date specified by Sponsor, the Winner may be disqualified and an alternate Winner may be selected in the Station's and Sponsor's sole discretion. Prize may not be assigned, transferred or changed, except at the Sponsor or Station sole discretion. The awarding of a prize is contingent upon full compliance with these Official Rules. Entrants agree to be bound by Official Rules and agree that if winner fails to provide proof of identity, refuses to provide required documentation, is found to have violated Official Rules, or otherwise does not meet eligibility criteria, prize will be forfeited and awarded to an alternate winner in a random drawing.

Eligibility: You must be 18 years of age at the time of entry. Only lawful residents of Kansas and Missouri in the Station listening area, 60 mile radius of Downtown Kansas City, Missouri,

are eligible to enter and win. Employees of Station and Sponsor, and their subsidiaries, affiliates or agents and their immediate family (parents, spouse, brother, sister or children) and individuals living in the same household of each of the foregoing are not eligible to enter or win. Void where prohibited by law. The Giveaway is subject to all applicable federal, state, and local laws and regulations. To Claim Prize: Prizes must be picked up at Station unless otherwise arranged with Station representative. If picking a prize up in person, a winner must provide photo identification in the form of a state issued I.D, Passport or birth certificate and social security card (if value of the prize is over \$600) . The potential winner will be required to complete, sign and return to Station an Affidavit of Eligibility and Liability/Publicity Release within 14 days of receipt of such documents from Station.
